

## **TERMS AND CONDITIONS OF “Poster Contest: Addressing Post MCO Issues” CONTEST**

This “Poster Contest: Addressing Post MCO Issues” Contest (hereby known as “Contest”) is organised by Universiti Telekom Sdn Bhd (Company No. 199701021324 (436821-T)), (hereby known as “UTSB and/or Organiser”). By entering and participating in this Contest, you are deemed to have read, understood and agreed to be bound by these Terms and Conditions.

### **1. Standard Terms**

- 1.1 Information on how to enter the Contest shall form part of the terms and conditions of entry.
- 1.2 This Contest is open to residents of Malaysia aged 16-18 years old, and who are currently undergoing their secondary education in Malaysia.
- 1.3 Only one entry will be accepted per person. Multiple entries from the same person will be disqualified.

### **2. Contest Period**

- 2.1 The Contest will commence and run from **6 July 2020 at 9.00 am and ends on 19 July 2020 at 11.59 pm** (“Contest Period”). Entries received after the end of Contest Period will be disqualified.
- 2.2 The Organiser may at its sole and absolute discretion extend the Contest Period at any time without any prior notice (hereby known as “the Extended Period”). Any participation in the Contest during the Extended Period (if any) is governed by these terms and conditions which shall remain in full force and effect and shall be read and construed to be enforceable.

### **3. How to Enter**

Participants are required to follow the steps below to participate in the Contest:

- 3.1 Go to <https://forms.gle/nv7VudGB1wEtbzas9> and complete the required details. For participants aged below 18 years old, you must obtain your parents/guardian’s written consent as provided in this link in order to proceed.
- 3.2 After completing the details, you are required to upload your poster in \*.pdf or \*.jpg format. The maximum file size is 10MB.

### **4. Participants’ Responsibilities**

Participants must ensure that all details given for the purpose of this Contest are true, correct and accurate. Participants must also ensure that the telephone number/email provided is in existence and are contactable. The Organiser reserves the rights to verify the information provided by the participants in any form it deems fit.

### **5. Selection of Contest Winners**

- 5.1 The Organiser has the right to determine the winners of this Contest at its sole discretion. Winners will be decided based on the following criteria: (i) concise and clear description on the usage of technology, (ii) creativity and novelty of the solution, (iii) practicality of the idea, (iv) style and presentation of drawing, and (v) grammar and spelling.
- 5.2 The Organiser's decision is final. No appeal via correspondence or attempts to appeal, review, dispute of such decision will be entertained.

## **6. Notification of Contest Winners**

- 6.1 The Contest winners and method of prize delivery will be announced and notified/contacted through the Organiser's phone call or any medium it deemed fit.
- 6.2 The Organiser shall not be responsible or be liable if any of the winners cannot be contacted. The Organiser further reserves the full right to disqualify any winner if any attempt to contact him/her has failed for any reason whatsoever.
- 6.3 The Organiser reserves the right to forfeit prizes if the Contest winner fails to provide the required details upon receiving the request/notification from the Organiser.

## **7. Copyright, Announcement and Confidentiality**

- 7.1 By entering into this Contest, the participants and/or winners hereby grant the Organiser perpetual and non-exclusive rights to broadcast the names, pictures or images or display any matter related to the participants and/or winners for publicity, advertising, trade or promotional purposes in any media without further notice. The participants and/or winners are not entitled to claim any payment in any form, fee or compensation for the use of their images or details in relation to the above.
- 7.2 The participants and/or winners acknowledge, understand and agree that their details may be shared by the Organiser to third party involved in this Contest (if any) for the purposes of the Contest. Any participants' information or personal data ("Personal Data") provided by the participants to the Organiser in connection with the Contest shall be kept confidential except to any related activities mentioned herein. The Organiser shall take all reasonable precautions to preserve the integrity, prevent any corruption or loss, damage or destruction of participants' Personal Data, and comply with the requirement of Personal Data Protection Act 2010.

## **8. Variation to the Terms and Conditions**

- 8.1 The Organiser reserves the rights to change, amend, delete or add to these Terms and Conditions either in written or verbal communications without prior notice at any time.
- 8.2 By participating in this Contest, the participants agree to be bound by this Terms and Conditions, notices, amendments and all decisions made by the Organiser.
- 8.3 In the event of any dispute, conflict, uncertainty or ambiguity relating to the Terms and Conditions hereto, or any matter involving this Contest, the Organiser will resolve the matter in its absolute and unfettered discretion and the entire decision in the matter shall be conclusive and final.

## **9. Liability**

- 9.1 The Organiser shall not be responsible or liable for any misinterpretation or misrepresentation of facts in respect of the prizes offered as published in any media, marketing or advertising materials.
- 9.2 The Organiser shall not be responsible or liable for any failure by any participants to participate in the Contest at any time.
- 9.3 The participants shall assume full liability in the case of any mishap, injury, damage, claim or accidents resulting from their participation in the Contest and/or collection of the prizes.
- 9.4 The Organiser shall not be liable for any failure to comply with its obligations where the failure is caused by something beyond its reasonable control. Such circumstances shall include, but not be limited to, weather conditions, fire, flood, hurricane, strike, industrial dispute, war, hostilities, political unrest, riots, civil commotion, inevitable accidents, supervening legislation or any circumstances amounting to *force majeure*.

- (a) That it determines to be tampering with the operation of the Contest; or
  - (b) To be acting in breach or potential breach of these Terms and Conditions; or
  - (c) For submitting incomplete, illegible or false entries; or
  - (d) For any other reasons stated in this Terms and Conditions.
- 10.2 The decision to disqualify shall be final and no correspondence shall be entertained.
- 10.3 The Organiser reserves the right, with or without cause, to exclude the participants and withhold prizes in the event of any violation by the participants to any of the Terms and Conditions herein.

**11. Suspension, Cancellation or Termination of Contest**

- 11.1 The Organiser reserves the right to cancel, suspend, delay or terminate the Contest at its absolute discretion without giving prior written notice to the participants or in the event of unforeseen circumstances beyond its reasonable control.
- 11.2 In the event of suspension, cancellation, delay or termination of the Contest for any reason by the Organiser, the participants shall not be entitled to make any claim or claim for compensation from the Organiser for any loss or damages suffered or incurred as a direct or indirect result of the said occurrence.

**12. Governing Law and Jurisdiction**

This Terms and Conditions are governed by the laws of Malaysia and any dispute arising out of or in connection with them shall subject to the exclusive jurisdiction of the courts in Malaysia.
