UPDATE ON MATTERS RELATED TO STUDENTS RETURNING TO CAMPUS FOR TRIMESTER 2 AND TRIMESTER 3, 2021/2022

INTRODUCTION

This announcement is an update on matters related to the reopening of campuses for Trimester 2 and Trimester 3, 2021/2022. Do read carefully so that you could make early preparations to return to campus.

ACADEMIC OPERATIONS

1. The University has decided that the teaching and learning process will be implemented as follows:

1.1 TRIMESTER 2, 2021/2022:

a) NEW STUDENTS FOR APRIL INTAKE 2022 *From 9 May 2022 – 7 August 2022*

- All students are required to be physically present on campus.
- All mass lectures will be conducted online.
- All tutorials, labs and studios will be conducted face-to-face beginning 16 May 2022 onwards.
- From 9 May 2022 - 13 May 2022, a special arrangement of online sessions will be made for all tutorials, labs and studios.
- The examination mode will be communicated by the respective faculties.

b) EXISTING STUDENTS OF ACADEMIC CALENDAR 2.0 (AC2.0) who follow Session 2 of Trimester 2 2021/2022 *From 9 May 2022 – 7 August 2022*

- Students are given options to be physically present on campus or study via online.
- All mass lectures will be conducted online.
- For the tutorials, labs or studios, please refer to the section that you have registered earlier.
- From 9 May 2022 - 13 May 2022, a special arrangement of online sessions will be made for all tutorials, labs and studios.
- Students who opted to return to campus, the face to face session for tutorials, labs and studios will begin from 16 May 2022 onwards.
- The examination mode will be communicated by the respective faculties.

1.2 TRIMESTER 3, 2021/2022:

- a) STUDENTS FOLLOWING ACADEMIC CALENDAR 1.0 (AC1.0)
From 6 June – 25 September 2022
- b) STUDENTS FOLLOWING ACADEMIC CALENDAR 2.0 (AC2.0)
From 8 August – 30 October 2022
 - Students are required to be present on campus.
 - All lectures will be conducted online.
 - All tutorial, labs and studios will be conducted face-to-face.
 - Examinations will be conducted physically on campus.

2. Students who are affected by COVID-19 (close contact with COVID-19 patients) or having tested positive during the teaching and learning period are required to notify their respective lecturers for further arrangements of the teaching and learning activities. Special hybrid classes will be arranged for students in this situation.

3. Kindly note that the University will always comply with decisions and any updated SOPs from the Ministry of Higher Education (MoHE) and Ministry of Health (MoH). Any related decisions will be updated to all students in a timely manner.

■ REQUIREMENTS FOR RETURNING TO CAMPUS

4. Students are required to conduct a COVID-19 self-test 24 hours prior to arriving to campus.
5. Students must use the MMU Mobile Apps for health declarations and to update the health status. Please download the MMU Mobile Apps from Apps Store.
6. Students who need assistance from the Student Affairs Department (STAD) should contact stad@mmu.edu.my or ssc@mmu.edu.my or isc@mmu.edu.my (visa/student pass matters).



ON-CAMPUS ACCOMMODATION

7. Students who wish to stay in the university's hostel, must apply and receive approval from the hostel management before returning to campus. Applications can be made via CAMSYS from 1 May until 31 May 2022.
8. Results of the hostel applications will be sent via email.

10. Shuttle services to and fro the university for students who stay off-campus are available for accommodation, selected locations and schedules. Students are advised to request for the service by emailing stad@mmu.edu.my)

VACCINATED AND UNVACCINATED STUDENTS

11. Considering the latest development of COVID-19, and as the country transitions to the endemic phase, the University has decided that all students including unvaccinated students will be allowed to enter MMU campuses and to attend face-to-face sessions. All students must strictly adhere to the SOP outlined by the university below:
 - 11.1 Students must wear facemasks in all campus buildings (Classrooms, Lecture Halls, Library, Labs etc.)
 - 11.2 Students are also encouraged to wear facemask at outdoor areas surrounding campus.
 - 11.3 Facemask can be removed when exercising indoors, when a person is by himself/herself, when eating and drinking, when making a speech, or when in a performance.
 - 11.4 Physical distancing on campus is encouraged.
 - 11.5 Practise good personal hygiene – wash hands and use hand sanitizer.



12. Unvaccinated students are required to do saliva test on a weekly basis and update the results on the MMU Mobile Apps.

SAFETY AND HEALTH

13. All students are required to adhere to the Ministry of Health's (MOH) Standard Operating Procedures and Guidelines.

14. Students with COVID-19 symptoms (high fever, cough, sore throat and flu) on campus are required to report to STAD officers at 01159349808 (Melaka Campus) or 01159309808 (Cyberjaya Campus).

15. Students who have been tested positive COVID-19 need to be quarantined and update the status in MySejahtera as per the Ministry of Health's (MOH) guidelines. Notify your faculty office and STAD office.
