A. MMU NEWBIE Rebate

A fee waiver programme for self-funded international students who enrolled into MMU Bachelor's Degree Programmes.

Criteria & Entitlement

Eligible for all new and progressing International Students enrolling in MMU Bachelor's Degree programmes.

A programme fee waiver programme for self-funded international students who excel academically after the announcement of their first long trimester result of Bachelor's Degree Programme in MMU.

Criteria & Entitlement	
CGPA 3.50 - 3.74	25%
CGPA 3.75 and above	50%



A. MMU SIBLINGS Discount



Criteria & Entitlement

One or two or more children having one or both parents in common. (This does not include family members outside sibling relationship such as fostered, step-brother / step-sister, godbrother / godsister etc.).

10% discount of programme Fees

The siblings must still be an active students pursuing the programme or have graduated from MMU.

B. MMU ALUMNI Discount



This discount is given to MMU Diploma Alumni or his/her children pursuing studies at MMU's Bachelor's Degree Programmes.

Criteria & Entitlement

Entitled for MMU Diploma students or MMU Alumni children pursuing degree programme in MMU.

10% of programme Fees

- 4. Discount is not applicable for payment of re-sit / re-take of subjects.

C. MMU STAFF Discount

MMU Staff and TM Assignee to MMU (Contract / Permanent) who have served a minimum of one (1) year service are eligible to apply for the discount of programme fees for themselves or their dependents studying in MMU. Dependents are defined as the employee's lawful husband/wife, legal children, legally stepchildren and adopted children.

Criteria & Entitlement	
10 years and above	50%
5 - 9 years	35%
1-4 years	25%
Expatriate - 5 years and above	20%
Expatriate – 1-4 years	10%
Retiree and Ex-Staff under separation scheme – minimum of 10 years continuous service	20%
Death in Service - minimum of 3 years continuous service	50%



- 1. Open to All programmes.
- 2. Students shall commence and finish the programme of study within the period stated in the offer letter.

 If students fail to finish their studies as scheduled, MMU reserves the right to terminate and withdraw the discount.
- No disciplinary case during the duration of studies. If students are found guilty of any disciplinary offence, MMU reserves the right to terminate and withdraw the discount.
- 4. The International Fee Rate is applicable to expatriate employees.
- 5. Staff who tendered for resignation or terminated from service are not eligible for the discount.

D. TM STAFF Discount

TM Staff and its subsidiaries (Contract / Permanent) who have served a minimum of one (1) year service are eligible to apply for the discount of programme fees for themselves or their dependents studying in MMU. Dependents are defined as the employee's lawful husband/wife, legal children, legally stepchildren and adopted children.

Criteria & Entitlement	
10 years and above	35%
1 - 9 years	25%
Expatriate - 5 years and above	20%
Expatriate - 1-4 years	10%
Retiree and Ex-Staff under separation scheme – minimum of 10 years continuous service	20%
Death in Service - minimum of 3 years continuous service	50%

GENERAL TERMS AND CONDITIONS


- Students must have received an offer letter of admission from Multimedia University for the 2025 intakes. 1.
- Students who meet the minimum criteria specified are eligible to apply for the scholarship. Meeting the minimum criteria does not automatically guarantee the student a scholarship.
- 3. MMU Scholarships, Financial Aid, and Rebates are available through applications that can be submitted at: https://www.mmu.edu.my/financial-assistance/. They will not be considered without an application.
- 4. Students are required to provide information on the family's financial position, as stated in the Scholarship Application form. MMU reserves the right to withdraw the Scholarship/Financial Aid application should the information furnished by the student be found to be false, misleading, or untrue.
- All scholarship applicants will be evaluated and shortlisted by the Scholarship Committee. The shortlisted students might be called for an interview.
- Students are only entitled to ONE MMU scholarship at any one time. (*Scholarships include scholarships, awards, discounts, and fee waivers). Combining scholarships/financial aids from MMU is NOT allowed.
- 7. Students may be awarded a sum that may be less than what is stipulated/published, depending on the availability of the Scholarship Fund.
- 8. The scholarship/tuition fee waiver and discount is not applicable for payment of re-sit/re-take of subjects.
- Students are required to pay any fees incurred that are not covered by the Scholarship/Financial Aid.
- 10. MMU reserves the right to revoke any scholarship due to termination of student status, withdrawal, or change of the programme before completion, and/or non-compliance with MMU Rules and Regulations or other Terms & Conditions of the scholarship. The student may be required to repay the scholarship/bursary amount used upon revocation.
- 11. The successful student must be willing and committed to participate in marketing activities organized by MMU.
- 12. Students are required to refer to the MMU Scholarship/Financial Aid Website for further information on the Scholarship/Financial Aid.
- 13. All scholarships/discounts are awarded on a first-come, first-served basis (where applicable), and are subject to the availability of the quota set in that particular scholarship category.
- 14. Scholarships, rebates or discount are not applicable to programmes that have already been discounted or are under a promotional package.
- 15. Students are required to comply with the Terms and Conditions in the Scholarship Agreement or the Letter of Award.
- 16. Late and incomplete application forms will not be considered for selection.
