



MMU POSTGRADUATE EXCELLENCE SCHOLARSHIP



A. MMU ACHIEVERS RESEARCH Scholarship

Awarded to students who have completed a Bachelor's degree **OR** Master's degree by Coursework/Mixed-Mode **OR** Master's degree by Research with the following criteria:

Programme Applied	Entry Qualification	Criteria
Master by Research	Bachelor's Degree	Minimum CGPA of 3.67
PhD by Research	Master's Degree by Coursework or Mixed Mode	Minimum CGPA of 3.67 AND Minimum 1 Scopus/WoS indexed journal paper (Accepted/Published)
PhD by Research	Master's Degree by Research	Minimum 2 Scopus/WoS indexed journal papers* (Accepted/Published)

**Note: 2 Scopus/WoS indexed conference papers are considered equivalent to 1 Scopus/WoS indexed journal*



Note

1. Application is open for Malaysian/International students.
2. Applicants must already have an offer letter but yet to register.
3. Scholarship is applicable only for Master's and Ph.D. programmes by research (full-time).
4. The Scholarship covers admission fee, programme fee, student development fee, subject fees and thesis examination fee within the duration of Scholarship.
5. All applicants will undergo an interview. The scholarship is awarded based on the outcome of interview. The decision of the adjudicating Scholarship committee is final.

B. MMU POSTGRADUATE MERIT Scholarship

Awarded to students who completed a Bachelor's Degree Programme from a recognised institution with minimum CGPA of 3.33 and consistently deliver outstanding results in their programme.

- All Postgraduate by Coursework programmes (including ODL) are eligible for this award.

Criteria & Entitlement	
CGPA 3.67 and above	50%
CGPA 3.33 – 3.66	25%

► Note

1. The application is open to Malaysian citizen only.
2. It is offered to Full-time and Part-time programme.
3. The scholarship is offered to those students that completed a Bachelor's Degree Programme from a recognised institution with minimum CGPA of 3.33 and successfully registered for the postgraduate programme listed.
4. All applicants will undergo an interview. The scholarship is awarded based on the outcome of interview.

C. MMU TALENT Scholarship

Awarded to students who have a proven track record of excellence in their respective field of talent, e.g. Sports, Music, Art, Debate, Theater, and Writing. Preference will be given to students who have proven track record in their respective field of talent at national or international level.

Criteria & Entitlement	
Representing University AND Won Medals, or received recognition award	50% waiver of programme and Hostel fees
Representing States AND Malaysia AND Won Medals, or received recognition award 1. State Athlete with verification letter from MSSM or SUKMA 2. National Athlete with verification letter from MSN or National Sports Association, or 3. Recommendation Letter from State / National coach	100% waiver of programme and Hostel fees

► Note

1. Malaysian citizen.
2. Open to All Postgraduate programmes.
3. The student needs to maintain a minimum CGPA of 3.00 for coursework based or the thesis-based students, need to achieve satisfactory progress status from supervisor.
4. The student must represent MMU in MASISWA, SUKIPT, other IPT Games, tournaments and other competitions as and when required by the University.
5. The scholarship will be reviewed on a yearly basis based on performance and achievements of the scholars in their respective field of talent. Scholarships can be revoked based on the discretion of the University.

MMU LOYALTY REBATES



A. MMU SIBLINGS Discount

The discount is given to new full time postgraduate by coursework students who have a sibling enrolled in MMU or graduated from MMU.

Criteria & Entitlement

One or two or more children having one or both parents in common. (This does not include family members outside sibling relationship such as fostered, step-brother / step-sister, godbrother / godsister etc.).

The siblings must still be an active students pursuing the programme or have graduated from MMU.

B. MMU ALUMNI Discount

A discount for MMU Bachelor's Degree Alumni and MMU Master's Degree Alumni pursuing studies into Postgraduate Programme.

Criteria & Entitlement

Entitled for MMU Bachelor's Degree Alumni and MMU Master's Degree Alumni to continue Postgraduate studies programme in MMU

20% discount of programme fees

C. MMU STAFF Discount

MMU Staff and TM Assignee to MMU (Contract / Permanent) who have served a minimum of one (1) year service are eligible to apply for the discount of programme fees for themselves or their dependents studying in MMU. Dependents are defined as the employee's lawful husband/wife, legal children, legally stepchildren and adopted children.

Criteria & Entitlement	
10 years and above	50%
5 – 9 years	35%
1- 4 years	25%
Expatriate – 5 years and above	20%
Expatriate – 1-4 years	10%
Retiree and Ex-Staff under separation scheme – minimum of 10 years continuous service	20%
Death in Service - minimum of 3 years continuous service	50%

1. Open to All programmes.
2. Students shall commence and finish the programme of study within the period stated in the offer letter. If students fail to finish their studies as scheduled, MMU reserves the right to terminate and withdraw the discount.
3. No disciplinary case during the duration of studies. If students are found guilty of any disciplinary offence, MMU reserves the right to terminate and withdraw the discount.
4. The International Fee Rate is applicable to expatriate employees.
5. Staff who tendered for resignation or terminated from service are not eligible for the discount.
6. Discount is not applicable for payment of re-sit / re-take of subjects.
7. No backdated discount will be given.
8. Terms and conditions apply.



D. TM STAFF Discount

TM Staff and its subsidiaries (Contract / Permanent) who have served a minimum of one (1) year service are eligible to apply for the discount of programme fees for themselves or their dependents studying in MMU. Dependents are defined as the employee's lawful husband/wife, legal children, legally stepchildren and adopted children.

Criteria & Entitlement	
10 years and above	35%
1 – 9 years	25%
Expatriate – 5 years and above	20%
Expatriate – 1- 4 years	10%
Retiree Ex-Staff, and Ex-Staff under separation scheme – minimum of 10 years continuous service	20%
Death in Service - minimum of 3 years continuous service	50%

1. Open to All programmes.
2. Students shall commence and finish the programme of study within the period stated in the offer letter. If students fail to finish their studies as scheduled, MMU reserves the right to terminate and withdraw the discount.
3. No disciplinary case during the duration of studies. If students are found guilty of any disciplinary offence, MMU reserves the right to terminate and withdraw the discount.
4. The International Fee Rate is applicable to expatriate employees.
5. Staff who tendered for resignation or terminated from service are not eligible for the discount.
6. Discount is not applicable for payment of re-sit / re-take of subjects.
7. No backdated discount will be given.

GENERAL TERMS AND CONDITIONS

1. Students must have received an offer letter of admission from Multimedia University for the 2026 intakes.
2. Students who meet the minimum criteria specified are eligible to apply for the scholarship. Meeting the minimum criteria does not automatically guarantee the student a scholarship.
3. Exception-MMU Merit Scholarship: Notwithstanding the above, for the MMU Merit Scholarship, applicants who meet the minimum eligibility criteria and submit a complete application will be automatically awarded the scholarship, subject to the approved quota and availability of funds.
4. MMU Scholarships, Financial Aid, and Rebates are available through applications that can be submitted at: <https://www.mmu.edu.my/financial-assistance/>. They will not be considered without an application.
5. Students are required to provide information on the family's financial position, as stated in the Scholarship Application form. MMU reserves the right to withdraw the Scholarship/Financial Aid application should the information furnished by the student be found to be false, misleading, or untrue.
6. All scholarship applicants will be evaluated and shortlisted by the Scholarship Committee. The shortlisted students might be called for an interview.
7. Students are only entitled to ONE MMU scholarship at any one time. (*Scholarships include scholarships, awards, discounts, and fee waivers). Combining scholarships/financial aids from MMU is NOT allowed.
8. Students may be awarded a sum that may be less than what is stipulated/published, depending on the availability of the Scholarship Fund.
9. The scholarship/tuition fee waiver and discount is not applicable for payment of re-sit/re-take of subjects.
10. Students are required to pay any fees incurred that are not covered by the Scholarship/Financial Aid.
11. MMU reserves the right to revoke any scholarship due to termination of student status, withdrawal, or change of the programme before completion, and/or non-compliance with MMU Rules and Regulations or other Terms & Conditions of the scholarship. The student may be required to repay the scholarship/bursary amount used upon revocation.
12. The successful student must be willing and committed to participate in marketing activities organized by MMU.
13. Students are required to refer to the MMU Scholarship/Financial Aid Website for further information on the Scholarship/Financial Aid.
14. All scholarships/discounts are awarded on a first-come, first-served basis (where applicable), and are subject to the availability of the quota set in that particular scholarship category.
15. Scholarships, rebates or discount are not applicable to programmes that have already been discounted or are under a promotional package.
16. Students are required to comply with the Terms and Conditions in the Scholarship Agreement or the Letter of Award.
17. Late and incomplete application forms will not be considered for selection.
